It is the responsibility of the permittee or the person doing the work to notify the Building Division for inspections at least twenty-four (24) hours in advance, and insure that the required inspections are made. **[A] 106.3.3 Time limitation of application:** An application for a permit for any proposed work shall be deemed to have been abandoned 180 days after the date of filing, unless such application has been pursued in good faith or a permit has been issued; except that the code official shall have the authority to grant one or more extensions of time for additional periods not exceeding 180 days each. The extension shall be requested in writing and justifiable cause demonstrated. The duty to insure code conformance rests with the builder, developer, or the homeowner, not the City of Brier. The approval of the construction plans and inspections does not guarantee that all the provisions of the applicable codes have been met. All documents submitted to the City become public record and are available for public inspection and copying. I herein agree to reimburse the City for the cost of professional engineers and other consultants hired by the City to review and inspect this proposal and any other related permits. *I represent the owner or contractor as signified above and am acting with the owner's/contractor's full knowledge or consent. I hereby request that the Building Department review be done parallel with other city department reviews. I understand that review by other departments and/ or changes resulting from these reviews may result in increased or additional charges or fees.*

- An expansion tank is required on all new water heater installations and dielectric insulators at all water heater connections.
- Shall have water hammer arrestors on all water systems and shall be accessible section 609.10. UPC.
- All bathtubs, whirlpools, showers, accessible and public lavatories without a single handle mixing valve shall have a mixing valve at the bathtub, whirlpool, shower, lavatory, or at the hot water heater per 2018 UPC sections 409 through 417.
- For all new and changed out heating and cooling units you shall submit calculations as stated in the Washington State Energy Code section 503.2.2 to the City's Building Department.
